SECOND VARIATION TO THE PRIMARY HEALTH ORGANISATION AGREEMENT VERSION 17

1. The existing Clause 2 of Schedule F1 is deleted and replaced with the following clause:

2. Management services

- 2.1 If your number of Enrolled Persons is 40,000 or below and we have approved a Management Services Plan that you have developed and submitted as set out in Schedule J10 then we will pay you a management services fee calculated per Enrolled Person according to the table below:

Numbers of Enrolled Persons	Management fee per Enrolled Person per year
Up to 20,000	\$13.87
20,001 to 40,000	\$0.80

- 2.2 If you are not covered by Clause 2.1 of this Schedule F1, we will pay you a management services fee calculated per Enrolled Person according to the tables below:

- (a) if your number of Enrolled Persons is 75,000 or below:

Numbers of Enrolled Persons	Management fee per Enrolled Person per year
Up to 20,000	\$9.87
20,001 to 75,000	\$4.80

- (b) if your number of Enrolled Persons is 75,001 or above:

Numbers of Enrolled Persons	Management fee per Enrolled Person per year
Up to 20,000	\$6.59
20,001 to 75,000	\$5.99
75,001 and above	\$5.39

The following Schedule J10 is added to Part J of the Agreement:

SCHEDULE J10 MANAGEMENT SERVICES PLANNING AND APPROVAL

1 Overview

- 1.1 As referenced in clause 2.2 of Schedule F1 this Schedule J10 details the process for PHOs that have fewer than 40,000 Enrolled Persons to develop and submit for our approval a Management Services Plan.

2 Development of Management Services Plan

- 2.1 We agree that you have fewer than 40,000 Enrolled Persons.
- 2.2 You agree to submit a management services plan to us. We will provide you with guidance about what to include in the plan.
- 2.3 We will notify you in writing about whether we approve your management services plan.
- 2.4 If we do not approve your plan we will clearly explain what you need to do to gain approval and work with you so that you can receive the increased management services fee.

3 Payment

- 3.1 We will pay you a once only payment of \$10,000 (GST exclusive) to develop and submit to us a management services plan.
